



## BEAUTYREST BLACK® AIRCOOL™ MATTRESS PROTECTOR

### PLEASE RETAIN PROOF OF PURCHASE FOR AT LEAST TEN YEARS FROM YOUR PURCHASE DATE.

If you purchased a Beautyrest Black® AirCool™ mattress protector/cover, this warranty covers manufacturing defects in your AirCool cover. If the laminate or fabric of the Product fails as a result of a defect in manufacturing in the course of normal usage during the 10 Year Warranty Period Simmons Bedding Company will replace the Product. This limited warranty is provided only to the original purchaser from Simmons Bedding Company or its authorized dealer. The "Warranty Period" shall mean the period commencing upon the date of purchase of the Product by the Purchaser and continuing (i) in the case of sales for HOUSEHOLD use (i.e., non-commercial use) for a period of TEN years.

In the event that the Product and a NEW mattress are purchased by an individual consumer for HOUSEHOLD use at the same time from the same authorized retailer, Simmons Bedding Company also warrants to the Purchaser that if the Product fails to protect (due to manufacturing defects in the Product) the mattress sleeping surface against staining while properly covered by the Product during shorter of the Warranty Period (defined above) or the warranty period offered on the mattress by the mattress manufacturer, then Simmons Bedding Company will, in its sole discretion, either have the mattress professionally cleaned (by a 3rd party), or replace the mattress with one of comparable quality and value, in each case provided the Purchaser complies with the conditions identified to the right:

### CONDITIONS TO WARRANTIES:

In addition, Simmons Bedding Company obligations under the foregoing warranties are subject to, and conditioned upon, compliance with the following conditions:

1. The Product must be laundered in accordance with the following laundering instructions and any other laundering instructions found on the care label on the Product: (A) Ensure that NO bleach or bleach alternative is used in the washing cycle; (B) DO NOT Dry in the dryer, dry flat; (C) Wash in temperatures not exceeding 40 degree Celsius or 104 degree Fahrenheit.
2. The Product must be inspected for damage after laundering, and use must be discontinued if damage is apparent.
3. Attempting to clean the stained mattress prior to or during the warranty process, unless otherwise instructed by the Beautyrest agent, will void the warranty.
4. The Product must not be subjected to abuse or improper installation or maintenance.
5. Any warranty claim must be submitted by contacting Beautyrest Consumer Service at the toll free telephone number or email listed below within 5 business days after the incident occurs for instructions to return the Product.
6. The Product must be returned to the Beautyrest Consumer Service Department, within 15 business days of receipt of the replacement Product, for inspection and validation in accordance with the instructions provided by Beautyrest when the claimant telephones Consumer Service as required above. DO NOT RETURN THE DAMAGED PRODUCT TO A RETAILER FROM WHOM YOU PURCHASED IT. A purchase invoice/receipt from an authorized distributor/reseller must be presented to make a warranty claim, within 15 days of when the claim was opened.



## BEAUTYREST BLACK® AIRCOOL™ MATTRESS PROTECTOR

### WHAT IS EXCLUDED?

- Normal wear and tear
- Damage due to improper cleaning of mattress cover.
- Stains caused by inks, nail polish, cosmetics, bleach, grease, alcohol, dyes, chemical hair treatments, self-tanning or tanning related chemicals or solvents.
- Stains or other damage during moves between residences, or while in storage, smoke, flood or other Acts of God
- Stains or damage caused by or the result of mold or mildew
- Stains or odors of unknown origin
- Theft, vandalism or other crimes, or any loss that is covered by an insurance policy
- Claims made outside the 50 United States, Puerto Rico or U.S. Virgin Islands
- Shipping costs- shipping documents or items to Simmons Bedding Company
- The warranty shall terminate in the event that Simmons Bedding Company satisfies its warranty obligations with respect to a claim; no subsequent claims will be covered for either the replacement Product or mattress in question.

The copy of the law tag and original copy of the bill of sale must be provided to identify the Beautyrest Black® AirCool™ Cover/Protector and validate this warranty.

The warranty in this paragraph shall terminate in the event that Simmons Bedding Company satisfies its warranty obligations under this paragraph with respect to a claim; no subsequent claims will be covered for either the replacement Product or mattress in question. Installing (or reinstalling after laundering) an obviously damaged Product voids the warranty in this paragraph. For the avoidance of doubt, the warranty in this paragraph does not apply to mattresses used commercially, the sides of the mattress or to ensembles (linens and mattress pads or toppers) and mattress bases (box springs or foundations), or mattresses not fitted with the Product

### HOW LONG IS THE COVERAGE PERIOD?

Warranty coverage is applicable for 10 years from the original date of purchase. Replacement of the AirCool™ cover/protector does not extend its limited warranty or begin a new limited warranty period.

### YOUR RIGHTS UNDER STATE LAW:

This warranty gives you specific rights, and you may have other rights, which vary from state to state.
