



BEAUTYREST BLACK® AIRCOOL™ PILLOW COVER

WHAT IS COVERED/WHAT WILL SIMMONS DO?

Please retain proof of purchase for at least THREE years from your purchase date.

If you purchased a Beautyrest Black® AirCool™ pillow cover, this warranty covers manufacturing defects in your AirCool cover. If the fabric of the Product fails as a result of a defect in manufacturing in the course of normal usage during the 3 Year Warranty Period Simmons Bedding Company will replace the Product. This limited warranty is provided only to the original purchaser from Simmons Bedding Company or its authorized dealer. The "Warranty Period" shall mean the period commencing upon the date of purchase of the Product by the Purchaser and continuing (i) in the case of sales for HOUSEHOLD use (i.e., non-commercial use) for a period of THREE years.

WHAT IS EXCLUDED UNDER THIS WARRANTY?

This warranty does not apply to:

- The Product must be laundered in accordance with the following laundering instructions and any other laundering instructions found on the care label on the Product: (A) Ensure that NO bleach or bleach alternative is used in the washing cycle; (B) DO NOT Dry in the dryer, dry flat; (C) Wash in temperatures not exceeding 40 degree Celsius or 104 degree Fahrenheit.
- The Product must be inspected for damage after laundering, and use must be discontinued if damage is apparent.
- Damage due to improper cleaning of Beautyrest Black® AirCool™ cover (includes snags and discoloration).
- Claims made outside the 50 United States, Puerto Rico or U.S. Virgin Islands.
- Shipping costs—shipping documents or items to Simmons Bedding Company.
- Beautyrest product that is burned, stained, soiled, cut or otherwise damaged or infested with vermin, even if defective. Simmons reserves the right to deny warranty coverage on such products.

HOW CAN I GET SERVICE ON MY 3 YEAR LIMITED WARRANTY?

The copy of the law tag and original copy of the bill of sale must be provided to identify the Beautyrest Black® AirCool™ Pillow Cover and validate this warranty.

The warranty in this paragraph shall terminate in the event that Simmons Bedding Company satisfies its warranty obligations under this paragraph with respect to a claim; no subsequent claims will be covered for the replacement Product in question. Installing (or reinstalling after laundering) an obviously damaged Product voids the warranty in this paragraph.

HOW LONG IS THE COVERAGE PERIOD?

Warranty coverage is applicable for 3 years from the original date of purchase. Replacement of the AirCool™ pillow cover does not extend its limited warranty or begin a new limited warranty period.

YOUR RIGHTS UNDER STATE LAW:

This warranty gives you specific rights, and you may have other rights, which vary from state to state.

THE DURATION OF ANY APPLICABLE IMPLIED WARRANTIES, INCLUDING BUT NOT LIMITED TO THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS, SHALL NOT EXCEED THE TERM OF THIS LIMITED WARRANTY. SIMMONS SHALL NOT BE LIABLE FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES THAT RESULT FROM THE USE OF YOUR BEAUTYREST® PRODUCT. NO EXPRESSED OR IMPLIED WARRANTIES ARE EXTENDED TO PERSONS WHO PURCHASE THE PRODUCT FROM ANYONE OTHER THAN SIMMONS BEDDING COMPANY OR ITS AUTHORIZED DEALERS, AND ALL WARRANTIES TO SUCH PERSONS, INCLUDING THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS, ARE HEREBY EXCLUDED.
